III. Key Issues Discussed

The BayREN PROP Report: Challenges and Opportunities

PowerPoint Presentation from Wes Sullens, BayREN/StopWaste

- Anecdotal evidence that there was significant anxiety as the new code came into effect
 - This was exacerbated because construction was starting to boom again and building departments were downsizing staff
- Building officials do not see themselves as having the authority to push applicants past minimum compliance



- Energy Division staff was really helpful in creating the report's call out box that explained the various definitions of "compliance."
- Is there a sense of the energy impact of the many errors found?
 - 51% percent of projects with errors were performing worse than predicted
 - This does not necessarily mean that those projects were out of compliance
 - The Plan Check program will be able to get more clarity on exactly what measures are error-prone, sacrificing the most energy
- The self-selection study design actually makes for a slight optimism bias these were probably the leading jurisdictions in terms of code enforcement.

Residential HVAC Alts. Permit Compliance

PowerPoint Presentation from Marissa Spata, CSE

- How did the CEC land on their compliance goal and how will they measure success?
 - Conducting a baseline compliance analysis: Comparing industry data to HERS data—unsuccessful in getting industry data at this point
- HVAC alteration checklists should not be longer than one page

Measure characterization list and rule set creation next steps

- Focus on repair indefinitely measures—there is more than enough savings potential there
- Start rule sets on the current policy
 - Identify barriers to overcome then build from there
 - Ideally a single rule set to make the process as simple as possible; however, there will probably have to be special criteria or steps for the different types
