- Energy Action Plan
 - “Meeting this goal requires the **cooperation and teamwork** of multiple sectors of the California economy,” (2008 Update, pg.2).
- CPUC Long-Term Strategic Plan
 - “California has taken this principle to heart and with three decades of **leadership and innovation** in the public and private sectors, California leads the nation, and perhaps the world, in developing and implementing successful energy efficiency efforts,” (pg.1).
- CAISO Energy Efficiency and Demand Response Roadmap
 - “Based upon input receive during the roadmap’s stakeholder process about the need for **collaboration**, the ISO, CPUC, and CEC are developing a cross-agency DR and EE workplan,” (pg.2).

New and Forthcoming Initiatives

- AB 32 and Prop 39 implementation facilitated through statewide approaches to developing statewide consistent savings estimates.
- EPA's proposed rule for regulating emissions from existing plans released June 1st
 - EPA released proposed rule for regulating carbon emissions from power plants on June 1, 2014, pursuant to Section 111(d) of the CAA
 - **Energy efficiency will very likely be accepted method for achieving compliance**
 - Cal TF may foster compliance using efficiency if it leads to **statewide** system of ex ante values for energy efficiency
