Cal TF develops 2 – 3
 policies to help guide
 new measure

- TF identifies cross-cutting policy issues that need to be addressed in ex ante measures development process, e.g.
 - Appropriate level of complexity/detail in measure development
 - What is "best available data?
 - When should measures "sunset"?
- Cal TF staff supports policy discussions through established subcommittee process, drafts policies based on TF input/discussion
- Resulting policy language may be submitted to CPUC, other entities for review

Metrics

 Cal TF releases RFQ for new TF members to be seated June 1, 2015

- Cal TF staff seeks feedback from TF members on who would like to continue on TF past June 1, 2015.
- Cal TF staff develops RFQ; solicits PAC approval and PAC reviewers.
- New TF members selected by June 1, 2015.

Goal 5. Develop "Future of Cal TF"





Metrics

Draft "Future Cal TF Vision" developed with input from PAC and TF

Fourth quarter 2015

- Cal TF staff consults with TF and PAC members on the possible future of the Cal TF, including work scope, possibilities of expanding/contracting
- PAC approves final version Q4 of 2015

Metrics

- Cal TF achieves metrics in Cal TF 2015 Business Plan
- Final report submitted to PAC Q2 2016

- Cal TF staff solicits feedback from PAC and TF on the value of Cal TF, areas for improvement
